The Undeniably Dairy Beat The Lag Contest ("Contest") is sponsored by Dairy Management, Inc., ("Sponsor"), 10255 W. Higgins Rd., Suite 900, Rosemont, IL 60018, and is administered by Prize Logic, LLC, ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. CONTEST PERIOD: The Contest submission period begins on May 14, 2021 at 12:00 PM Eastern Time ("ET") and ends on May 29, 2021 at 11:59:59 PM ET ("Submission Period") and is followed by a judging period which begins on May 30, 2021 at 12:01 AM ET and ends on June 11, 2021 at 11:59:59 PM ET ("Judging Period"). The Submission Period and Judging Period are collectively the "Contest Period." The Administrator's computer is the Contest's official clock.
- 2. **ELIGIBILITY:** This Contest is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least thirteen (13) years old at the time of entry. Employees of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies or other entities involved in the development, judging or fulfillment of the Contest (collectively, "Contest Entities") and each of their immediate family members (*e.g.*, spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes Entrant's (defined below) full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Contest. Any Entrant who is under 18 years of age or otherwise under the legal age of majority in the jurisdiction in which the Entrant resides must obtain permission to enter from his/her parent or legal guardian, and the agreement of the parent/legal guardian to these Official Rules, prior to entry.

3. HOW TO ENTER: During the Submission Period an eligible entrant ("Entrant" or "you") must log on to either their Twitter Account or Instagram Account and upload a video, photograph(s) or GIF showing their original simple (5 ingredients or less) dairy-based, recipe along with the hashtag #BeatTheLagContest and tagging @dairygood (collectively, the "Entry"). Entrant must "follow" @dairygood during the Contest Period and for a period of thirty (30) days thereafter for prize notification purposes. Recipe element of Entry must include at least one (1) dairy ingredient and be themed to be an ideal dish or snack to enjoy while gaming that helps you "Beat the Lag." You can include the recipe in your Entry via post copy, text overlay, or verbal instructions (video). Videos should not exceed sixty (60) seconds. You may submit up to ten (10) photos in a single Entry post via Instagram (carousel) and up to four (4) photos in a single Entry Tweet. Additional requirements for the Entry are set forth at Rule 4 below. Following a valid Instagram or Twitter post that complies with these Official Rules, an Entrant will receive one (1) Entry into the Contest.

Entry Limit: There is a limit of two (2) Entries (1 for Twitter and 1 for Instagram) per person per day during the Submission Period. You can use the same recipe in your Entry via both Twitter and Instagram in a single day, however any new Entries on additional days of the Submission Period must feature a different recipe. An entrant cannot submit the same Entry more than once per social media

platform for an Entry into the Contest. For purposes of this Contest, a day is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET except on the Contest start date of May 14, 2021, when a day will start at 12:00 PM ET.

VIA INSTAGRAM: If an Entrant participates on Instagram, they must have their own active Instagram account with a non-private setting as of the date of Entry and throughout the Contest Period. Entrants may create an Instagram account at no cost by logging on to http://instagram.com. Creation of an Instagram account requires Entrant to agree to Instagram's Terms of Service and Privacy Policy, available at http://instagram.com/about/legal/terms/ and http://instagram.com/about/legal/terms/ and http://instagram.com/about/legal/terms/ and http://instagram.com/about/legal/privacy/, respectively. Due to the way Instagram operate its services, entries from Instagram users with "protected" accounts (i.e., Entrant has set their account to private so that only people the Entrant has approved can view his or her updates) will not be eligible.

VIA TWITTER: If an Entrant participates on Twitter, they must have their own active Twitter account with a non-private setting as of the date of Entry and throughout the Contest Period. Entrants may create a Twitter account at no cost by logging on to http://twitter.com. Use of Twitter will be subject to that service provider's privacy policy and terms of use. Due to the way Twitter operates its services, all Tweets submitted as Entries must be public in order for entry to be eligible.

Further, Entrant hereby understands and agrees that, at Sponsor's sole discretion, their Entry may be posted to the Website, Sponsor's Twitter account, Sponsor's Instagram account, or other social media sites associated with the Sponsor.

A mobile device is not required to participate in this Contest, but if an Entrant elects to enter the Contest on their mobile device, message and data rates may apply. Entrants should consult their wireless service provider regarding its' pricing plans. Entrants should review their mobile device's capabilities for specific app instructions.

- **4. ENTRY GUIDELINES AND REQUIREMENTS/REPRESENTATIONS AND WARRANTIES:** Each Entrant (and Entrant's parent/legal guardian if Entrant is a minor) represents and warrants as follows with respect to Entries:
 - Must be in English;
 - Must comply with Twitter's or Instagram's posting requirements depending upon the platform on which the Entry is posted;
 - Must contain the hashtag #BeatTheLagContest and tag @dairygood;
 - Must not have been previously published or submitted previously in a promotion of any kind or won a prize or award;

- Must be the original work of the Entrant and must not contain images or artwork, music, quotes, parodies or other materials not created by Entrant. In connection with the recipe element of the Entry: an original recipe is created by Entrant and not copied from another source. You must either take the photo or video yourself or if someone else takes it, you must require the photographer (non-professional) to grant you ownership before you submit it and make clear the photo/video will be submitted in this Contest for use by Sponsor;
- Must not be defamatory or libelous or invade the publicity or privacy rights of any third party or contain material that violates or infringes another's rights, including, but not limited to, privacy, publicity or intellectual property rights, including copyright infringement, or legal or moral rights of any third party, living or deceased;
- Must not contain any commercial, political, religious, or other third party advertising or messaging;
- Must have approval from any persons appearing in the Entry and the Entrant must be able to
 provide express written consent of every such person appearing in the Entry (or if such person
 is a under 18 years old, then express written consent of the minor's parent/guardian) to Sponsor
 and/or Administrator if requested;.
- Must be in keeping with Sponsor's image and not be offensive and not disparage Sponsor,
 Administrator, or any other person or party;
- Must not include personally identifiable information;
- Must not include use of any logos, brand names or trademarks (including but not limited to any branded recipe ingredients, video games, or gaming systems) other than Sponsor's, which Sponsor has granted Entrant, with respect to the Sponsor's trademarks, a limited license to use for purposes of this Contest as set forth in Section 5 of these Official Rules.
- Must not contain, facilitate, reference, or use material that is dangerous, fraudulent, inappropriate, indecent, lewd, violent, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous:
- Must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - any cruelty to, or mistreatment in any way of animals;
 - gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age; and
- Must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where Entry is created or otherwise promotes any unlawful, illegal, unsafe, dangerous or reckless behavior.

NOTE: If any Entry fails to comply with any of these Entry Guidelines and Requirements or any other provisions of these Official Rules, Sponsor reserves the right, in its sole discretion, to disqualify the Entrant and the Entry will not be eligible to win.

5. SPONSOR'S IP AND GENERAL ENTRY TERMS: Sponsor grants Entrants a limited, revocable, non-sublicensable license to use Sponsor's name, product, trademarks and logos (collectively, "Sponsor's IP") for the sole purpose of participating in this Contest. Entrants are not permitted to make any further

use of Sponsor's IP for any purpose whatsoever. In addition, Entrants recognize that all rights, title, and interest in Sponsor's IP shall vest exclusively to the Sponsor, and Entrant agrees that he or she has not and will not take any action that might harm or adversely affect such rights. No right, title, or interest in and to the Sponsor's IP except for the limited license granted to Entrant in these Official Rules is transferred or created. Each Entrant further acknowledges and agrees that Sponsor's IP rights are valid and enforceable, and that Entrant shall do nothing to challenge the validity or enforceability of Sponsor's IP in any forum. Entrants agree that the use of Sponsor's IP is permitted only for the purpose of making an Entry in this Contest, and that any use of Sponsor's IP (whether in the Entry or otherwise) beyond this scope infringes the rights of Sponsor and will result in irreparable harm to Sponsor.

Grant of Rights: Each Entrant retains ownership of their Entry. Each Entrant (and Entrant's parent/ legal guardian if Entrant is a minor) represents and warrants that he/she has the right to grant and hereby grants to Sponsor and its affiliated companies and designees, licensees, successors and assigns a non-exclusive, transferable, perpetual, irrevocable, royalty free, worldwide, unconditional, fully paid license and right to post, publish, use, copy, reproduce, modify, edit, adapt, incorporate it into other works, and create derivative works of the Entry and/or any materials provided by the Entrant with the Entry or otherwise through the Contest (collectively "Contest Materials"), (b) to publicly perform or display, import, broadcast or transmit, distribute (directly and indirectly), license, offer to sell and sell, rent, lease, or lend copies of the Contest Materials (and derivative works thereof), and (c) to sublicense to third parties the foregoing rights, in any and all media now known or hereafter developed, without consideration and without review, approval or notice, to the extent permitted by law. This license expressly includes a right (but not the obligation) for Sponsor to modify Contest Materials to remove any third party intellectual property. Additionally each Entrant consents to the use of his/her name, statements, photographs, videos, voice recordings and likenesses of himself/herself and any other person appearing in the Contest Materials for publicity purposes, as well as any other purpose associated with the Contest.

Once an Entry is entered into the Contest, it may be made available on Sponsor's Channels for viewing by the general public, and any such posting will be deemed made at the direction of the Entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act. EACH ENTRANT REPRESENTS, UNDERSTANDS AND ACKNOWLEDGES THAT THEY WILL NOT BE PAID FOR OR RECEIVE ANY FORM OF COMPENSATION OR ROYALTY (OTHER THAN THE PRIZES STATED HEREIN IF SELECTED AS A WINNER) IN EXCHANGE FOR GRANTING SPONSOR THE NON-EXCLUSIVE LICENSE RIGHTS OR FOR ANY SUBSEQUENT USE OF SUCH ENTRY BY SPONSOR. If requested, Entrant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights Entrant is granting to use the Entry. If Entries are, in Sponsor's sole discretion, displayed on Sponsor Channels, Entrants understand and agree that such Entries may be subject to third party comments that will be publicly viewable, and further, such Entries may also be sayed, shared, and/or further emailed by such third parties on the internet or otherwise, and Sponsor and the other Contest Entities shall have no liability for such third party actions. Further, Sponsor, at its sole discretion, may add or remove any Entry from the Sponsor Channels at any time for whatever reason. The displaying of an Entry on the Sponsor Channels does not constitute verification of eligibility or compliance with these Official Rules, and is no indication of Sponsor's or Judge's opinion about such Entry. Each Entrant (and Entrant's parent/legal guardian if Entrant is a minor) hereby agrees to indemnify and hold the Contest Entities harmless from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of Entrant hereunder.

If Sponsor is duly notified that any element of an Entry infringes upon the rights of another person, and/or receives a legally valid request to remove the affected Entry from Sponsor Channels, such Entry may be disqualified from the Contest, as Sponsor may determine in its sole discretion. Further, no Entrant will be eligible to receive a prize unless Sponsor determines, in its sole and absolute discretion, that such Entrant's Entry has been or can be sufficiently cleared for legal purposes (e.g., for the purpose of the Contest and/or Sponsor's other intended uses), and such Entrant's eligibility is verified. **Entrant (and Entrant's parent/legal guardian if Entrant is a minor) will not take any action that interferes**

with the rights granted to Sponsor under these Official Rules

6. JUDGING: During the Judging Period, all eligible Entries will be judged by qualified judges selected by Sponsor in its' sole discretion ("Judges"). The Judges will score each Entry according to the following weighted criteria: (i) Creativity: 33% (how unique and original is it); (ii) Presentation/Appeal: 33% (what is the perceived taste appeal and how is it presented in the Entry); and (iii) Relevance to the "Beat the Lag" theme with a snack/dish that includes dairy: 34% (does the Entry display clear inspiration from eating/snacking during gaming and include dairy in its 5 ingredients or less,)All of these factors determine the Entry's overall "Judges' Score". The one (1) Entry that receives the highest Judges' Score will be the potential grand prize winner and the next four (4) Entries with the highest Judges' Score will be the potential first prize winners, subject to verification of eligibility and compliance with these Official Rules for a total of five (5) winning Entries in all (one [1] grand prize winner and four [4] first prize winners). In the event of any ties at any prize level, the tied Entries at that level will be reviewed by the Judges and the tie will be won by the Entry with the highest score in criteria (iii) "Relevance to the "Beat the Lag" theme with a snack/dish that includes dairy. If there is still a tie, the tied Entries will be re-judged (by a Judge who did not judge in the original round) to determine the winner. If a winner is found to be ineligible or does not comply with these Official Rules, they will be disqualified and the Entry with the next-highest Judge's Score will be named the potential winner. Administrator's, Judge's and Sponsor's decisions shall be final and binding in all matters pertaining to the judging and selection of the winner.

7. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):

- **A. Grand Prize.** There is One (1) grand prize available to be won ("Grand Prize"). One (1) Grand Prize winner will receive a gaming suite package consisting of:
 - Gaming PC
 - 34" Monitor
 - Gaming headset (with sound mixer)
 - Microphone
 - Swivel mount microphone boom arm
 - · Illuminated mechanical gaming Keyboard
 - Mouse with charging dock
 - Gaming chair.

The ARV of the Grand Prize is \$3,855.

- **B.** First Prizes. There are four (4) first prizes available to be won (each a "First Prize"). Each First Prize winner will receive a 34' monitor and gaming headset with sound mixer. The ARV of each First Prize is \$1,500.
- C. Total ARV of Prizes: The total ARV of all Prizes available in this Contest is: \$9,775.
- D. General Prize Restrictions and Limitations: In no event will more than the number of prizes stated in these Official Rules be awarded. ALL WINNERS WILL BE ISSUED A FORM 1099 FOR TAX PURPOSES IN THE AMOUNT OF THE ACTUAL RETAIL VALUE OF THE PRIZE. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any prize won. Prize is non-assignable and non-transferable and no prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. Limit: one (1) Prize per person. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility.
- **8. HOW TO CLAIM A PRIZE**: On or about June 14, 2021 the potential winners will be notified via direct message from @dairygood on Twitter if a winning Entry was posted on Twitter or via direct message on Instagram if the winning Entry was posted on Instagram (the "Notification"). The potential winner

must then respond to the Notification within three (3) calendar days and provide their complete first and last name (no initials), street address (no PO Boxes), city, state, Zip Code, valid e-mail address, and date of birth.

All prize winners (and winner's parent/legal guardian if winner is a minor) will be required to execute an Affidavit of Eligibility, a Liability Release and (where imposing such condition is legal) a Publicity Release (collectively, "Prize Claim Documents") within five (5) business days from the date that the email containing the documents is sent to the potential winner. If the potential winner fails or refuses to sign and return all Prize Claim Documents within the five (5) business days time period, the potential winner may be disqualified, at the Sponsor's sole discretion.

LIMITATION OF LIABILITY: By participating in this Contest, Entrants (and Entrant's parent/legal quardian if Entrant is a minor) agree that the Contest Entities, Twitter, Instagram, and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, Web masters and their respective officers, directors, employees, representatives, designees and agents ("Released Parties") are not responsible or liable for: (i) lost, late, incomplete, stolen, misdirected, postage due, or undeliverable email notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/website/use net accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing, or typographical or other error; or unauthorized human intervention; (v) the incorrect or inaccurate capture of Entry information, or the failure to capture, or loss of, any such information; ((vi) any error, omission, incorrect or inaccurate information, whether caused by any website's users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Contest; (vii) any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from participating in the Contest and/or accepting a prize; (viii) Entries that are entered by any automated computer, program, mechanism or device, or for any Entries in excess of the stated limit, or for Entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules, and all such Entries may, in Sponsor's sole discretion, be disqualified.

Sponsor reserves the right to not award Contest prize(s) if, in its sole discretion, it does not receive a sufficient number of qualified Entries.
